- I. Approval of November 2017 minutes: unanimously approved
- II. Director's Report
 - A. Extended hours (29) and 2018 office schedule posted on County website.
 - B. Law Enforcement Initiative: 2017 funds of \$869.00 collected last summer
 - C. Community Outreach Efforts
 - Working with Nadia Rajsz: Cultural education on HOMODOR, the Russian/Ukranian Famine from the 1930's. These atrocities haven't received much attention. There may be controversy, but it is important to have the discussion. There will be an exhibit in the Government Center Lobby in Dec. 2018 (HR week).
 - 2. Satellite HRC office at local libraries: last Wednesday of the month. Ari will be available for people who want to meet outside of the government center.
 - 3. HRC presence at local town and village board meetings. Commissioners should make appoint of attending, introduce the HRC, leave brochures, etc.
 - D. County Policy on Expenses and Contracts Ari stressed the importance of everyone following these policies in every case.
 - All expenses must be authorized by the Executive Director by first establishing that proposed expenses:
 - · meet County policies, and
 - funds are available and in the proper GL budget line,
 - submitting a requisition,
 - procuring Purchase Order
 - following up with detailed invoice, internal confirmation/documentation, and voucher

III. Committee Reports

- A. Executive Committee did not meet in person because of weather
 - 1. Strategic Plan Meeting
 - Board Vacancies two HRC vacancies are currently posted on the website. Roland is retiring and Peggy is stepping down.(See her letter below*)
 - 3. Eileen Weil Scholarship Annual brunch committee met. Decision was made to place accumulated money into Community Foundation of Orange & Sullivan. Once it reaches \$25,000, it will continue to grow in perpetuity. To use the foundation, a special law has to be passed. Judy is working on this with County Legal. Honorees chosen:

 - Martin Colavito community/human rights activist
 - Elaine Williams community/human rights activist
 - Roland Ward acknowledgement for his service on his retirement from the HRC
