**II.** <u>MINUTES:</u> E. Benson made a motion to accept the minutes from the March 14, 2022, board meeting, J. Diehl seconded, no one opposed, the motion was passed and carried.

## IV. OLD BUSINESS:

- A. Neversink/Rondout Grant: See written report
  - Construction bids for Denning Road and Ladleton stream were opened.

Baker Bros-\$ 901,312.00 LaFever- \$1,028,917.00 Hubble - \$1,169,768.00 Evergreen -\$1,590,511.00

As Baker was the lowest bid, R. Kaplan made a motion to approve and accept the bid from Baker and to move forward with the contract, N. Rajsz seconded the motion, the motion was passed and carried.

- A. Neversink/Rondout Grant: continued
  - A request to raise an hourly wage for a seasonal position salary of \$18 per hour was requested from the Neversink office and was discussed. The District Board felt \$18 per hour was a reasonable hourly rate and requested what was advertised for the position. If it was \$18 per hour, then that is where it should remain.
- B. Program Updates:
  - Flood mitigation Looking at projects for this year with NYS DEC rep B. Drumm. Hoping to finish some projects by end of August.
  - The Burlingame site will be a good project for part C funds.
  - Tree & Shrub Program was a success. We had 166 orders. Discussed programs being easier and less time consuming if ordering was put online and accepting orders.

# V. <u>NEW BUSINESS</u>:

- A. Bank Statements: The bank statements were reviewed.
- B. Technician Position: The Board discussed the hiring of a technician to train with present staff. Salary can be funded from Part C funds. The decision was to wait to hire more staff until a commitment is given from present employees to retire or leave.
- C. Create a list of projects for the District.
- D. Brian proposed submitting a Climate Resilient Farming grant. Board discussed and R. Kaplan made a motion for a resolution to submit the RFP, E. Benson seconded, motion was passed and carried.
- E. The WQCC savings account being held at Catskill Hudson Bank has gone dormant. N. Rajsz made a motion to close account and move funds to Jeff Bank, J. Diehl seconded, motion was passed and carried. Will look into WQCC and how to use the remaining funds.
- VI. <u>DISTRICT CLAIMS</u>: E. Benson made a motion to approve abstracts, bills and pre-approvals, seconded by N. Rajsz, no one opposed, the motion was passed and carried.
