
SULLIVAN COUNTY SEEKING INPUT ON TELECOMMUNICATIONS ACCESS, SURVEY LAUNCHED TO HELP COUNTY PLAN FOR EXPANDED SERVICE AND SEEK FUNDING

Sullivan County residents, business owners, and visitors are all encouraged to participate in a new survey about broadband internet and cell phone service that is being conducted by the Sullivan County Division of Planning and Environmental Management (DPEM). Strong participation in the survey is important to help the County plan, advocate, and seek funding for service expansion and improvements.

The survey can be completed online at <https://surveymonkey.com/s/sullivanbroadband> or at the Sullivan County website, <http://co.sullivan.ny.us>. Paper copies will be available at Town and Village halls, public libraries, and other venues, and can also be obtained by calling DPEM at (845) 807-0527. Additionally, paper copies are being mailed to addresses shown on County coverage maps as not having access to wireline broadband.

Although the New York State Broadband Office maintains maps showing where people have access to high speed internet, these official maps appear to report that more of Sullivan County has access to service than is actually the case. Additionally, coverage maps do not measure or document other types of information needed for applications to state and federal funding programs, such as the quality of service and how Sullivan County residents use their internet. The survey is intended to collect information required to make the case for expanded telecommunications services in Sullivan County, and is part of an ongoing initiative to work with service providers, funding agencies, local municipalities and consumers to increase internet access and cell phone coverage.

HOTEL & MOTEL ROOM OCCUPANCY TAX

The Sullivan County Treasurer's Office would like to remind all residents that there is a Hotel & Motel Room Occupancy Tax that has been in effect since 1989.

This law includes anyone who rents out a building or portion of a building for lodging on an overnight basis including, but not limited to, hotels, motels, personal homes, inns, bungalow colonies, clubs, boarding houses, and bed & breakfasts. All of these entities are required to apply for a Room Tax Certificate through the Sullivan County Treasurer's Office, which authorizes them to collect the 5% Room Tax on behalf of the Treasurer and submit this tax to the Treasurer's Office on a quarterly basis.

SERVING THOSE WHO HAVE SERVED THEIR COUNTRY

For those who have served their country in one of the branches of the U.S. Military, there are a variety of programs available. One program that a veteran may be eligible for is VA Medical, the Nation's largest integrated health care system.

VA Medical provides comprehensive medical care and enrollment should be considered by all Veterans. Basic eligibility requires active duty service (other than for training only) and a discharge under conditions other than dishonorable. There are however many other requirements and conditions that must be met for enrollment.

The Sullivan County Veterans Service Agency is ready to explain this program, eligibility requirements and assist with the completion of the 1010EZ application form.

The VA Medical application, like all requests for VA benefits, requires a DD-214 or a Discharge Document (WWII Veterans) to be included with submission. If you do not have proof of discharge, our office will assist you with completion and submission of a SF-180, Request for Military Records. Military service and medical treatment records may also be requested with this form. The request can be submitted on the internet, however, the form must be signed in order to be processed.

The same SF-180 form may be used to request medals, decorations, and awards earned by a service member. Next of kin may also use this form to request a reissue (a death certificate is required in these instances).

If you are a veteran of the U.S. Military, we encourage you to contact the Sullivan County Veterans Service Agency and make sure that you have maximized your access to the programs and services that you have earned. The phone number is (845) 807-0233.

SULLIVAN COUNTY PROBATION: PROVIDING PUBLIC SAFETY FOR OVER FIVE DECADES



The Sullivan County Probation Department is the second oldest in New York State, having been established on July 1, 1960 after a pilot program that was initiated during 1959. The objective of Probation supervision is first and foremost ensuring public safety while preparing a probationer for an independent law-abiding lifestyle. Due to the variety of functions performed by Probation, the department is organized into specialized units.

Intake provides preliminary proceedings for Family Court regarding issues of domestic violence (family offenses) and juvenile delinquency complaints. It provides intervention services for individuals and their families including assessment and referrals to various providers without formal court proceedings. This results in time and cost savings to the community through the diversion of JD cases from Family Court and avoidance of long-term intervention and costly out-of-home placements.

Investigations and reports for the Criminal and Family Courts constitute an important part of probation work. Pre-Sentence Reports (for criminal courts) and Pre-Disposition Reports (for Family Court) provide a concise record of the subject's legal and social background, an analysis of both, and a recommendation for disposition, primarily to assist in the judicial decision making process. The reports are also relied upon by Probation Officers assigned supervision of a probationer for planning and risk classification. Additionally, Pre-Sentence Reports of defendants sentenced to prison by the County Court are utilized by the NYS DOCCS to classify inmates for placement in appropriate correctional facilities, as well as programs for inmates, etc. At the same time, the NYS Division of Parole utilizes the Pre-Sentence Report to calculate possible release dates and begin planning for post-release supervision.

At the time of sentencing, Conditions of Probation are imposed by the Court and the Probation Department is charged with supervising the probationer and enforcing these conditions. The Department also collects DNA samples from probationers for submission to the NYS DNA Databank. The Probation Department additionally supervises probationers from other states and counties.

Juveniles on probation pursuant to Family Court Order are at greater risk of out-of-home (and out-of-county) institutional placement. These juveniles are intensively supervised in the community by a probation officer.

In addition to general supervision caseloads, the Department has a variety of specialized caseloads supervised by officers with appropriate training for high-risk sex offenders, DWI, youthful offenders, domestic violence probationers, as well as Family Court juvenile offenders.

The Alternatives to Incarceration Program (ATI) began in 1987 as a response to the overcrowding situation in our local jail. This program allows for a reduced jail population with a significant savings for the County.

The Community Service Program allows selected offenders to perform hours at local public and not-for-profit agencies. Offenders are sentenced to perform anywhere from 10-500 hours in lieu of jail time. There are many worksites throughout the County, including local DPWs, Sullivan Renaissance, litter-pluck projects, United Way, CACHE, SPCA, churches and food pantries.

The Pre-Trial Release Program (PTR) allows defendants, who cannot post bail, to be screened and interviewed via video conferencing for possible release. If deemed appropriate, he or she is monitored by a Probation Officer until the court renders a disposition or sentence. The program has a low FTA rate (failure to report), which is the cornerstone of the program's existence. Overall, this program helps alleviate jail overcrowding with a substantial savings for the County.

Probation is a conduit for the various courts to ensure victims are reimbursed for their losses and court fines/surcharges are paid. During 2014, \$86,073 in restitution was disbursed to victims. Additional funds were added to the County's general fund due to the collection of probation supervision fees, restitution surcharges, and court fines.

As one can see, the Probation Department covers a wide breadth of functions while meeting its primary obligation of ensuring public safety.
