Group Picnic Permits are required for all groups larger than 25 people. Group picnics are permitted in most Sullivan County Parks from May through October, daily from 9:00am until 7:00pm. Group size may not exceed 200 ppl. in most parks. (See Pavilion & Park Capacity on attached information page). Permit applications are available beginning January 1 of the current year and are issued on a first come first serve basis.

Application Fees are due at time of application. Upon receipt of completed application and fees a permit will be issued providing the date requested is available. No application refunds are given due to weather conditions or cancellations. Security deposits will be returned upon approval after inspection of park grounds or upon cancellation of permit, if cancellation occurs at least 2 weeks prior to permit date.

## Rules and Regulations

- Group picnic permits do **not** grant exclusive use of park to group. Park shall remain open to public.
- A group Picnic Permit does **not** constitute a waiver of any applicable user fees which must be paid at point of entry to the park.
- Sullivan County will not provide tables or other items in addition to what is present at each site. It is the responsibility of the Permittee to verify the available facility.
- Groups, who violate these rules and regulations, fail to properly clean up after their picnic, cause damage to facilities, are larger than arranged for, or are misleading in their application are subject to the loss of their security deposit.
- The Permittee must have their Group Picnic Permit in their possession at the time of picnic.
- Alcoholic beverages, illegal drugs, and smoking are **prohibited** on **all** park property.
- Vehicles must remain on designated roads and parking areas.
- Cooking is allowed on supplied barbecue grills only. Hot coals must remain in the grills. **NO OPEN FIRES!**
- All minor children **must** be supervised by a responsible adult at all times.
- **No** swimming at any park except at the designated swim area at Lake Superior's beach during specific beach operating hours when lifeguards are on duty. The swim area is closed at all other times.
- **All County Park Rules and Regulations must be adhered to.**

**All trash shall be properly disposed of in the garbage cans provided. Any excess debris or damage will be the responsibility of the permit holder and will result in the forfeiture of the security deposit. Please separate clean RECYCABLES and place in proper bins.**



**Items which are NOT allowed in parks include but are not limited to:**

Inflatable products (moon jumps, bounce houses), tents, bands, disc jockeys, PA systems, generators for electricity, portable bathrooms, commercial uses or productions, circus acts, petting zoos, public displays regardless of being for profit or not for profit, use of propane grills, food vendors, glass containers, etc.

**By signing this application the applicant agrees that he/she is solely responsible and answerable in damages for any and all accidents or injuries to persons (including death) or property within the boundaries of said premises and hereby covenants and agrees to hold harmless the County of Sullivan, the Sullivan County Legislatures, Sullivan County Parks and Recreation Department, Sullivan County Division of Public Works, their officers, agents and employees from all claims, actions, damage and costs of every nature and description arising out of or in any way connected with this Group Picnic Permit.**
