- County cut of \$83,000
- Federal cut of \$33,000

 - o This will save approximately \$10,000
 - Will start April 8th
- A fund appeal to the general public will be made
- There will be possible lay-offs after the furlough ends
- Programs will have to be cut

- Motion to continue with the furlough and send out the press release regarding the furlough and financial situation was made by Earl, seconded by Sonja, all in favor, passed
