- Statement of Financial Position ending 7/31/13 was distributed

- Budget and building are two separate issues and building ownership should not lower our appropriation
- ESNY has been funded for the 2013-2014 year
 - Spending during the Federal government shutdown may not be reimbursed
- Staff buyouts on vacation for those that left this year were underestimated
- Change in vacation policy will lower the accrued vacation amount carryover and payout
