### Minutes

**II.** <u>MINUTES:</u> Harold Russell made a motion to approve the minutes from the March 9, 2015 meeting, Kitty Vetter seconded, the motion was passed and carried.

## IV. OLD BUSINESS:

A. Neversink/Rondout Grant: See written report

- Contract is still waiting for final approval by NYC DEP and NYS Comptroller. It may be June before funds could be received.
- Accepting applications for SMIP grants. Have received five apps between Town of Neversink and Town of Denning. An application has been received from C. Smyth, Town Historian, for education.
- Action plan is ready and will be reviewed by WAG committee in April.
- Flood Analysis- With warmer weather the staff will be able to do the final data collection needed for B & L to finish the model. A public meeting will then be set.
- There were two proposals received in response to the RFP for finishing plants for the CSBI projects. One proposal was dismissed due to incomplete data. The second was above the threshold but we are working with that company to negotiate an acceptable cost. If a proposal is not accepted, the next step may be that each District will house their own plants.
- Held the programs second annual Hemlock Woolly Adelgid summit meeting on April 2 at Frost Valley for possible solutions to prevent further hemlock decline.
- Brenden Wagner is working on a proposal to return as a summer intern for research. A possible start date may be beginning of June but will not happen until the new contract is in place and funding has been received.

### B. COLA:

Directors discussed employee cost of living increase that has been postponed from previous meetings. B. Kaplan recommended a 2% increase. H. Russell made a motion for a 2% COLA increase, retroactive to January 1<sup>st</sup>, W. Hughson seconded, the motion was passed and carried.

C. No-Till Seeder:

- Received a quote from Truax for \$31,000. Brian is working on getting quotes from local distributors.
- Lisa will check with County Planning Department on the small Ag grant for partial cost. Remaining cost will come from District through funds received by NYS Dept. Ag & Markets for Performance Measures that need to be used for new programs.

# V. <u>NEW BUSINESS</u>:

A. Bank Reconciliation: The March bank reconciliation was reviewed.

B. County Audit: Auditors were here on April 2<sup>nd</sup> and 8<sup>th</sup>. Audit seems to have gone well.
